<u>PLEASE READ</u>: You may feature one roughstock event and one timed event. Feature event prize money cannot be more than double that of the remaining open events. 2nd division events prize money must not exceed 50% of that in the corresponding open event.

How to calculate the Committee Levy: Timed Events - Rodeos posting prize money form \$0 to \$2000 will receive 2.5% of posted prize money for all timed events to a maximum of \$35. Prize money over \$3000 per event will receive a maximum \$40 per entry. Roughstock - Rodeos posting prize money up to \$1000 per event will receive 3% of the posted prize money and 3.5% for \$1001 and over to a maximum of \$45. <u>Capping Entries</u>: Any rodeo which contends it suffers from an excessive number of entries may apply for special consideration at time of approval. Special considerations must be approved by the Board of Directors.

<u>Non APRA Events At Your Rodeo</u>: If an event you wish to run is not on the above list you must fill out the accompanying Non-Approved Event Application Form and submit it with this form for consideration. One event per form. If you run any events not approved by the APRA you may not be covered by the APRA's insurance policy and you may void your affiliation.

Affiliation with the APRA does not cover contract acts eg: Comedy Clown, Band, Trade Sites. These parties must have their own public liability insurance.

The principal name on this form will be responsible for any outstanding monies owed to the Association.
